As West Virginia's State Treasurer, I am pleased to inform you that the West Virginia Cash Now program found \$2,086.31 in the West Virginia State Treasurer's unclaimed property database that belongs to you. You will receive your check along with a list of your properties in October. If your above listed address is correct, all you must do is check your mailbox in October, open the letter, and cash your check.

The purpose of this letter is to notify you that you have been identified as an unclaimed property owner through the **West Virginia Cash Now** program and to assure you that this program is a valid state program and not a scam. This program allows my Office's Unclaimed Property Division to cross-check databases, proactively locate certain types of unclaimed property owners, and automatically initiate payment without the need for additional paperwork. Please review the name and address listed above. If this information is correct, **no action is required** on your part to receive these funds. In October, a check will be mailed to you at the address listed above. **If any of the information above is incorrect, please contact the Unclaimed Property Division at 1-800-642-8687 or email WVCashNow@wvsto.gov and reference the Claim ID listed above.** If this letter was sent to a previous address and then forwarded to you by the postal service, please contact us as soon as possible to update your address. Checks sent out in October will NOT be forwarded to your new address and will be returned to my office as unclaimed property unless you contact us to update your information.

While I am pleased to have matched you with this property, we may be holding other unclaimed property that belongs to you which could not be matched through this program. I encourage you and your family members to visit www.wvunclaimedproperty.gov to search for other unclaimed properties. 
What to look for:

What's inside:

- Letter clearly marked with the following:
 - West Virginia Cash Now logo
 - Unclaimed Property return address
 - State Treasurer's name
 - Your name and address
 - Your Claim ID
- Your Unclaimed Property check from the State of West Virginia
 - Sealed, with perforated edges
 - State of West Virginia return address



What to do next:

Cash or deposit your check!

- Check must be cashed within six months
- If a check is not cashed, funds will be returned to the Treasurer's Office as unclaimed property
