Question 1

Do you have the complete configuration part # for the Sophos XGS 3300 appliances? I believe Sophos offers different packages for this appliances and coverage (with Standard or XStream protection, either in 1 year or 5 year coverage). Can you let us know what option you need for the appliance since we were not able to locate this information on the documentation?

<u>Answer 1</u>: We are intentionally not providing specific Sophos part numbers for individual items or bundles in order to give resellers flexibility to quote the best pricing possible, utilizing whatever bundles or offers are available to them from Sophos. We have included the mandatory functionality required in section 4 which can be summarized as two (2) XGS 3300 security appliances which will function in an active-passive HA configuration and includes licenses/subscriptions for 5 years of XStream Protection, 5-years of Webserver Protection and 5-years of Enhanced to Enhanced Plus support upgrade.

Question 2

For the last three line item for the subscriptions, are these new licenses or renewals for existing appliances?

<u>Answer 2:</u> The WVSTO does not currently own any XGS-series Sophos security appliances. Line items 4.1.1, 4.1.2 and 4.1.3 are new subscriptions for the security appliances in line item 4.1. As outlined in the answer to the question above, whether these are sold separately or included as part of a bundle with one of the security appliances is up to the individual reseller based on the best pricing available.

Question 3

Could you please send the SOPHOS License ID's?

<u>Answer 3:</u> These are new licenses as the WVSTO does not currently own any XGS series appliances so there are currently no license IDs for XStream.
